NOTICE INVITING e-TENDER

Item rate tenders are invited through the e-tendering portal by Manager(Electrical), (Bid Manager) (Mobile no.-9836061112) on behalf of Chief Executive Officer, AAICLAS from the eligible contractors for the work of "R & M other Electrical Works at NSCBI Airport, SH:- Operation and Maintenance of Fire Fighting pumps and Sewerage pumps at NICT." at an estimated cost of Rs. 61,87,785/- (excluding GST) with period of completion 36 (Thirty six) months.

The tendering process is online at e-portal URL address https://etender.gov.in./eprocure/app or https://aaiclas-ecom.org. Aspiring bidders may download and go through the tender document.

Prospective Tenderers are advised to get themselves register at CPP-portal, obtain 'login ID' & 'Password' and go through the instructions available in the Home Page after log in to the CPP-portal https://etender.gov.in./eprocure/app or aaiclas-ecom.org. They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their application. The process normally takes 03 days' time.

Tender fee of **Rs 1120/-** (i/c GST) Non-refundable will be required to be paid offline in the form of Demand Draft from Nationalized or any scheduled Bank(but not from co-operative or Gramin Bank). The original Demand Draft against Tender fee should reach by post/courier/given in person to the concerned officials, within 3 days of the last date of bid submission or as specified in the Tender .

Document. The details of Demand Draft / any other accepted instruments, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time.

Envelope-I: - Containing qualifying requirements of Contractor/ Firm: -

The tenderer shall be submit their application only at CPP portal https://etenders.gov.in/eprocure/app

Tenderer/ Contractor are advised to follow the instruction provided in the tender document for online submission of bids. Tenders are required to upload the digitally signed file of scanned documents along with scanned copy of Demand Draft for Tender Fee. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

Qualifying requirements of contractors/ firms.

- i) Agency should have Permanent Account Number (PAN).
- ii) Agency should have valid Registration on the Date of issue of Tender in appropriate class of CPWD/MES/P&T/Railways/State PWD/PSU/Municipal Corporations & Development Authorities of Delhi, Mumbai, Chennai and Kolkata.

OR

Agency should have satisfactorily completed (Phase/Part completion of the scope of work in a contract shall not be considered, however pre-determined phasing of the work will be accepted) three works, each of Rs.24,75,114 /- or two works, each of Rs. 30,93,893/- or one work of Rs. 49,50,228/- in single contract of similar nature i.e. Maintenance fire fighting pumps, Jockey pumps 7 Sewerage Pumps etc during last seven years ending on 31.03.2019 in India...

"The value of executed works shalf be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid".

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Firms showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources certificate in support of their claim for having experience of stipulated value of work.

Should have annualized average financial turnover of **Rs. 18,56,335.5/-** against works executed during of the previous last three years ending 31st March financial year. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the firm should be submitted along with the application. Firms showing continuous losses during the last three years in the balance sheet shall be summarily rejected.

Should possess (***Concrete Batching Plant, Comprized Hot mix Plant, Paver etc.) documentary proof of owning and possess required along with the application. In case agency do not the swing possess required plant and machinery, an undertaking to this proof them, to be submitted along with the application and deployment shall be as per requirement at site decided by the Engineer In-Charge.

Envelope-II: - Technical Bid containing scanned copy of Unconditional Acceptance of AAICLAS's Tender Conditions and EMD.

Scanned copy of earnest money deposit (EMD) of value **Rs. 1,23,755.70**/- in the form of Demand Draft / FDR / Bank Guarantee as stipulated in the notice inviting tender may be submitted in "Tech Bid Folder" in Technical Bid / Attachments section of e-tendering portal along with Unconditional Acceptance of AAICLAS's Tender Conditions (Performa given in Tender Document).

Envelope-III: - The Financial e-Bid through CPP portal.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

- 2. Original EMD, hard copy of signed Unconditional Acceptance of AAICLAS's Tender Conditions to be sent to the Regional Manager, NICT Building, NSCBI Airport ,Kolkata 700 052 and should reach to Bid Manager before the date & time mentioned in CRITICAL DATA SHEET. Tender of the tenderer whose EMD and unconditional acceptance of AAICLAS's tender conditions are not received by the time of the opening of pre-qualification of tender then their tenders will be summarily rejected. Any postal delay will not be entertained..
- 3. Bids Opening Process is as below: -

Envelope-I: Containing Documents for pre-qualification bid (uploaded by the contractors / firms) shall be opened as per **CRITICAL DATA SHEET**. The intimation regarding acceptance/rejection of their bids will be intimated to the contractors/ firms through e-tendering portal.

Envelope-II: Technical bid opening date shall be as mentioned in **CRITICAL DATA SHEET.** (Depending on pre-qualification, any change in the date shall be intimated through CPP portal).

If any clarification is needed from the bidder about the deficiency in his uploaded documents in Envelop – I and Envelope –II, he will be asked to provide it through CPP portal. The bidder shall upload the requisite clarification/documents within time specified by AAICLAS, failing which tender will be liable for rejection.

Envelope-III: The financial bids of the contractors/firms found to be meeting the qualifying requirements and technical criteria shall be as per CRITICAL DATA SHEET. (Depending on Technical Bid evaluation the date shall be intimated through CPP portal).

- 4. AAICLAS reserves the right to accept or reject any or all applications without assigning any reasons. AAICLAS also reserves the right to call off tender process at any stage without assigning any reason.
- 5. AAICLAS reserve the right to disallow issue of tender document to working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/Temporary/Permanent debar by any department of AAICLAS. AAICLAS reserve the right to verify the credential submitted by the agency at any stage (before or after the award the work). If at any stage, any information/documents submitted by the applicant is found to be incorrect/false or have some discrepancy which disqualifies the firm then AAICLAS shall take the following action:
 - a) Forfeit the entire amount of EMD submitted by the firm.
 - b) The agency shall be liable for debarment from tendering in AAICLAS, apart from any other appropriate contractual/legal action.

SPECIAL CONDITION OF CONTRACT

Name of Work :- R & M Other Electrical works at NSCBI Airport , .SH: Operation & maintenance of Fire Fighting Pumps and Sewerage pumps at Integrated Cargo Complex

These Additional conditions shall be read in conjunction with the General conditions of the contract (GCC). In case of any discrepancy between these additional conditions and the GCC, the later shall have the overriding value.

1. LOCATION & GENERAL DESCRIPTION

The work is to be carried out at NICT, NSCBI Airport, Kolkata .the prospective tenderer is advised to visit the site before quoting for the work and no claim whatsoever account of any discrepancies at site shall be entertained like security restrictions, inaccessibility and local rules by laws etc.

The contracts covers AMC of all fire fighting pumps installed at new International Cargo Complex, which involves operation, repair & maintenance, clearing etc., as required attending to complaints/faults/breakdown and taking proper rectification action,ensuring serviceability/satisfactory working condition of the systems,preventive maintenance, documentation etc.as per good engineering practice, terms and conditions covered under this contact on round the clock basis on all days including Sunday and Holidays etc and replacement of battery terminals & other minor spares/items as required at site, as per instructions of engineer -in- charge

2. Minimum Manpower Requirement: -

The tenderer has to depute following minimum manpower per day for the contract to maintain the installations on 24 hours basis including Sunday & Holidays. Other Manpower, for any repair & maintenance, cleaning, etc. as required, shall be provided by the contractor, with in the quoted rate.

FOR SHIFT DUTY

Skilled (Operator) - 03 Nos (Reliever Extra)

Unskilled (Helper) -03 Nos (Reliver Extra)

Besides the above one Mechanic/Electrician/Wire man should check the installation at least once in a week and whenever required in case of emergency.

- 3. The Original installations shall not be distributed/modified without instructions in writing of Engineer-in-charge from time to time depending upon operational & technical requirement.
- 4. Security/Airport Entry Pass: The Contractor shall arrange Security/Airport Entry Pass, their personnel and the cost of making tokens/Entry Pass etc. shall be borne by the Contractor. The Contractor shall be responsible for misuse of any token/Entry Pass and be liable for account by

security agencies at the Airport.

- 5. Addition of new installations: During the contract period. AAICLA may include various new installations to exiting installations and the contractor shall be responsible to operate & maintain those installations also as per specification.
- 6. Compliance of the provisions of Statutory requirements: The contractor shall comply with all necessary rules & regulations of central/local state government related to the contract and the contractors shall be responsible to maintain all requisite documents for reference to statutory authorities and AAICLAS, as & when asked for any expenditure in compliances with the statuatory requirements related to the contract shall be borne by the contractor.

The Contractor shall be responsible for the following points during period of contracts:-

- i) The Contractor will be bound by the labour laws, industrial rules and the contract labour (Regulation and Abolition) Act 1970 with up to date amendments.
- ii) The minimum wages shall be payable as per rules/notification of the Regional Labour Commissioner (Central) time to time Contractor shall also make extra wage payment to the staff on duty for THREE NATIONAL HOLIDAYS during calender year. No extra /additional payment shall be made to the contractor on account of the above.
